Terms & Conditions:

- The DDSEs/Principals of the District/Office concerned, from where the transfers are being effected, shall release the transferee with immediate effect from the date of issue of this Order.
- In the event of release Order not being issued within the period specified above, the transferees will be deemed released/stand released from the present place of posting after 10 (ten) days of issue of this Order. The salary of the transferees shall not be drawn anymore from the present place of posting, thereafter.
- The DDSEs/HoD of the District/Office concerned shall submit compliance report/ATR on SI Nos 1 & 2 latest by 15/08/2026.
- The DDSEs/Principals of the Districts concerned, from where the transfers are being effected shall release the transferees from their respective Districts even if there is mismatch in the details relating to the current place of posting (school details) indicated in respect of the transferee.
- The above rationalization / transfer and posting has been done through automated Teachers Registry Portal, for equitable distribution of teachers.
- If any information about teachers / DDSEs / Principals is found to be false or if any material fact has been suppressed by the transferee teachers / DDSEs / Principals shall be liable for action as deemed fit by the Government under the CCS (Conduct) Rules 1965.
- In case where teachers were earlier transferred / posted within the district vide orders issued in April, 2026, and their names have subsequently been included again under the present State Rationalization / Transfer & Posting Order, the earlier transfer / posting orders shall stand superseded to that extent with immediate effect. The present postings, as reflected in this Order, have been finalized through the Automated Teachers Registry Portal (TRP) under the rationalization exercise.
- It is observed that the automated Transfer and Posting Orders issued through the Teachers Registry Portal (TRP) for PRTs and TGTs (Elementary) indicate specific subjects. Since the TRP is designed to rationalize teachers based on the minimum teacher requirement in schools, the subject indicated in the order shall be read as "All Subjects."
